Date, Time and Venue of Physical Efficiency Test, Practical Test and certificate verification will be intimated in due course.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents to prove age, qualification etc at the time of verification of original documents. SC/ST candidates shall produce community certificate in Form No.III issued under rule 4 of the Kerala (SC&ST) regulations of issue of community certificate rules 2002 or Online Community Certificate with digital signature issued by the Competent Authority.

Note :- (7) Copy of answer scripts of the OMR Test held on **04/04/2018** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER V11(3)4265/18/EW dated 16/11/18**.
