The above vacancies are now in existence. OMR Test will be conducted as the first stage of the selection. The list of selected candidates published by the Commission in pursuance of this Notification shall remain in force for a minimum period of One year and a maximim period of three years provided that list will not continue to be in force if a new Ranked List after the expiry of minimum period of one year is published. Candidate will be advised against the vacancies shown above and for all the vacancies reported during the period of pendency of the Ranked List.

- Note:- (i) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the service of any of the institutions under its purview if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.
  - (ii) The selection to the concern will be subject to the rules and regulations made from time to time.

- Note: (i) The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It should also be clearly specified in the certificate that they were not working in the regular service of the concern. The over aged candidates who become eligible to be included in the Ranked List on the basis their provisional service Company/Corporation/ in anv Board/Authority/Society will be considered only in the vacancies reported by the same concerned, in which they have worked provisionally.
  - (ii) The retrenched employees of the Kerala Fisheries Corporation will be given age relaxation as stipulated in the G.O.(Rt)No.1942/84/PW dtd. 31.12.1984 to the extent of their service subject to the condition that the maximum age limit shall not exceed 50 years.
