Applications are invited only Online from qualified candidates from Hindu Nadar Community of Kerala State for appointment in the undermentioned post in Kerala Government Service. This is the II NCA notification due to the non availability of Hindu Nadar candidates for the post as per First NCA Notification dated 31.12.2012 (Category No. 693/12).

1. **Department** : State Water Transport
2. **Name of post** : Syrang
3. **Scale of pay** : ₹ 9940-16580/-
4. **Number of vacancy** : 1 (One) (Hindu Nadar)

5. **Method of appointment** : Direct Recruitment (From the above mentioned community only).

6. **Age limit** : 19-39. Only candidates born between 02.01.1976 and 01.01.1996 (both dates included) are eligible to apply for this post. (Including the relaxation as per para 2(i) of the General Conditions. For conditions regarding other age relaxation, please see Para 2 of the General Conditions)

7. **Qualifications** :
1. Literacy in Malayalam or Tamil or Kannada.
  2. Possession of current Syrang Licence.

Note: 1. Candidates should possess current Syrang Licence through out all the stages of selection process as on the last date for receipt of application, OMR Test, practical test , interview etc..

They must quote the User-ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected.
