NOTIFICATION

The following list contains the names of candidates found suitable by the Commission on the basis of the result of the objective (OMR) type test held on 03.09.2014, Practical Test held from 23.02.2016 to 05.03.2016 for the selection to the post of **Driver Gr. II (LDV) (By Transfer) in Various Department in Idukki District (Cat.No. 017/14)** and arranged in the order of merit. The Ranked List is brought into force with effect from 06.02.2018.

The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But re-checking of marks will be done on payment of **Rs.75/-** (Rupees Seventy Five only) in any one of the Treasuries in the State under the Head of Account "**0051 PSC,105 State PSC, 99 Examination Fee**". The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidate from this office. Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from Commission's **Website www.keralapsc.gov.in** or photocopied therefrom. Applications submitted in any other manner will not be considered. The valid applications for rechecking of answer script along with the original chalan receipt for prescribed fee addressed to the District Officer, Kerala Public Service Commission District Office, Idukki, Kattappana P.O., shall reach this office within 45 days from the date on which the ranked list has come into force (i.e. the date on which the ranked list has been approved by the Commission).

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs. 300/-**(Rupees Three Hundred only) by way of challan in any of the treasuries in the State (Head of Account **0051 PSC -800 State PSC -99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original challan should be submitted to the District Officer, K.P.S.C District Office, Kattappana P.O, Idukki within 45 days from the date on which the Ranked List is brought into force. **A copy of the answer sheet will be issued only once to a candidate.** Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceeding will be initiated against those who do so.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal,affidavit certified by notary and a self attested copy of photo affixed ID Card. The request for relinquishment received within 15 days from the date of publication of Ranked List in the Official Website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.”

Valid applications for rechecking/photocopy of answer script along with the original chalan receipt should reach the **District Officer, K.P.S.C District Office, Kattappana P.O, Idukki** shall reach this office on or before 23.03.2018 (I.e, the date on which the Ranked List has been approved by the Commission). Applications for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
