The last date for receipt of applications for rechecking/obtaining photocopy of the answer script is **22.03.2018.** Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries put in column 8 (community) are based on the communities specified by the candidates in their applications and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, KPSC District Office, Thrissur within one month from the date of publication of the Ranked List, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal and an affidavit attested by Notary and a self attested photo affixed ID card. The request for relinquishment received within 15 days from the date of publication of the Ranked List in the official website will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List.
