NOTIFICATION

The following is the Ranked list of candidates for the post of **DRIVER GRADE II (LDV)** (**BY TRANSFER**) (Category No. 17/2014) on ₹ 9190-15780/- in **Various Departments** in **Kozhikode District** notified in the Gazette dated 15.03.2014 found suitable by the Commission and arranged in the order of merit based on the marks secured in OMR Test held on 03.09.2014 and Practical Test 19.12.2016. The Ranked List is brought into force with effect from **06.02.2018**.

Separate Ranked List will be prepared for each districts in pursuance of this notification. The Ranked List thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment in the ratio of 1:3 for by transfer and Direct recruitment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidates is advised from the Ranked List till the expiry of the period of three years the duration of the Ranked List shall be extended for a further period of one year or till atleast one candidate is advised from the list whichever is earlier. In the absence of suitable candidates for appointment by transfer the vacancy shall be filled up by Direct recruitment.

According to the existing procedure, revaluation of Answer Script is not allowed. But answer scripts will be re- checked, to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers, if the candidates apply for rechecking, remitting the prescribed fee of ₹ 75/- (Rupees Seventy Five only) in any one of the Treasuries in "0051 PSC 105 State PSC 99 Examination Fee". the State under the Head of Account Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed A4 size from the Commission's paper website/www.keralapsc.gov.in / or photocopied therefrom. Applications submitted in any other manner will not be considered. The application for rechecking along with the original chalan receipt should reach the District Officer, Kerala Public Service Commission District Office, Civil Station, Kozhikode within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission). Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of ₹ 300/- (Rupees Three hundred only) by way of chalan in any of the treasuries in the State under the Head of Account "0051 PSC-800 State PSC 99 other receipts". The duly filled up application in the prescribed form (available in the commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, K.P.S.C District Office, Civil Station, Kozhikode within 45 days from the date on which the Ranked List has come into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

"Any Candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal, an Affidavit attested by Notary and a self attested photo affixed ID Card. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised."

Valid applications for rechecking/ photocopy of answer script addressed to the District Officer, K.P.S.C District Office, Civil Station, Kozhikode - 673 020 shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/ photocopy of answer script is **22.03.2018**. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
