The duly filled in application in the prescribed form(available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to DEPUTY SECRETARY (EXAMINATIONS) - II, KERALA PUBLIC SERVICE COMMISSION, PATTOM.P.O, THIRUVANANTHAPURAM - 695004 within 45 days from the date on which this ranked list is brought into force. The copy of an answersheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 08/06/18 . Applications received after the prescribed date will not be entertained.				
Note (2)	:- A period of 45 days time to apply for rechecking of answerscripts will be allowed to candidates with effect from the date on which this ranked list is brought into force. The candidates can avail only one chance. "Applications for rechecking of answerscripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or it's photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered." Note (3)	:- Since a common Written Test/ OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.				
Note (4)	:- The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.				
Note (5)	:-"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of the State/Central Government with Signature, Name, Designation and Office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions.
