Note :- (6) SC/ST candidates included in the probability list are required to produce community certificate issued by the revenue authority as per Rule(4) of Kerala (SC&ST) Regulations of Issue of Community Certificate Rules,2002 and candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **09/02/2017** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ERIII(3)4539/17/EW Dated 15/12/2017**.
