**NOTE (1) :-** The Ranked List will be in force for a minimum period of one year provided that the said Ranked List will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations)-I, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE (3) :-** Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark for OMR test relating to all candidates appear for the test will be published only after the publication of entire Ranked Lists( including NCA Notifications)which will be finalised on the basis of the common test.

**NOTE (4) :-** The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of Ranked Lists for all the posts finalised on the basis of the common test.

**NOTE (5) :-** Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an identity proof bearing a photograph as enlisted in the general conditions . The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
