Note :- (6) Candidates belonging to SC/ST communities shall upload in profile and produce in person the Community certificate obtained from Revenue authorities not below the rank of Tahsildar along with the other documents mentioned above at the time of verification.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.
