Note:- (5) SC/ST Candidates included in the Short list are required to produce Community Certificate issued by the Revenue Authority as per Rule(4) of Kerala (SC&ST) regulations of Issue of Community Certificate Rules,2002 and candidates belonging to Other Backward Classes included in this list are required to produce Non-Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **31/12/2013** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
