Note :- (6) SC/ST candidates included in the probability list are required to produce community certificate issued by the revenue authority as per Rule(4) of Kerala (SC&ST) Regulations of Issue of Community Certificate Rules,2002 and candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **27/09/2014** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
