Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so.</p> <p>Note (2) : Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal.
