Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked to those candidates who, apply for the same remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST candidates included in the short list are required to produce community certificates issued by the revenue authority and candidates belonging to Other Backward Classes included in this short list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **27/09/2016** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
