## NOTIFICATION

The following list contains the name of candidates found suitable by the Commission on the basis of the result of the Objective Type (OMR Valuation) Test held on 18/09/2015 and Practical Test held on 28/03/2017 for selection to the post of Driver Gr-II - HDV (2<sup>nd</sup> NCA OX) on ₹ 9190-15780 in Various Departments (Except NCC, Tourism, Excise, Police and Transport) in Pathanamthitta District (Category No.775/2014) notified in the Gazette dated 31/12/2014 and arranged in the order of merit.

The Ranked List is brought into force with effect from **31/05/2017**. And will be valid until candidates are advised and appointed against the vacancies that arise due to the paucity of the candidates belonging to Other Christian Community, during the currency of Ranked List published on 10/11/2006 (Cat. No.91/2004) for the above post.

The entries put in Column 9 of the Ranked List are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Pathanamthitta within one month from the date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

According to the existing procedure, re-valuation of answer script is not allowed. But answer scripts will be rechecked to see that all the answers are valued and that there is no mistake in the totalling of marks for various answers if the candidate apply for rechecking remitting the prescribed fee of ₹75/- (Rupees Seventy Five Only) in any one of the Treasuries in the State under the Head of Account '0051 PSC-105 State PSC-99 Examination Fee' and original chalan should be enclosed with the application.

Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied therefrom. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the <a href="District Officer">District Officer</a>, <a href="K.P.S.C. District Office">K.P.S.C. District Office</a>, <a href="Pathanamthitta">Pathanamthitta</a> within 45 days from the date on which this Ranked List is brought into force. (ie., the date on which the Ranked List has been approved by the Commission).

In the case of candidates who send applications for re-checking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above the marks awarded will be re-checked and the result of the re-checking will be intimated to the candidates from this office. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of ₹ 300/- (Rupees Three Hundred Only) by way of chalan in any of the Treasuries in the State under the Head of Account 0051 PSC-800-State PSC-99-Other receipts. The duly filled up application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, KPSC District Office, Pathanamthitta within 45 days from the date on which the ranked list is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The last date for receipt of applications for rechecking/photocopy of answer script is 14/07/2017. Application for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisition of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised."
