The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the Joint Secretary (Online Examinations), Kerala Public Service Commission, Pattom, Thiruvananthapuram - 4 within 45 days from the date of approval of this ranked list (on or before 19/01/2018). The printout of the answer sheet will be issued only once to a candidate. Printout of answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
