- (ii) The candidates belonging to above reservation community shall submit application for the post to the Kannur district where the vacancy is existing and shall note the name of that district against the relevant column of the Online application.
- (iii) In the case of change in caste/community noted in the SSLC Book ,candidates must claim their original caste/community in the application and shallproduce caste /communitycertificate orNon-Creamy Layer Certificate as the case may be issued by the Revenue Authorities and the original Gazette Notification publishing the change of caste /community at the time of OTR verification for selection to the above post
- (iv) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in the same department in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- 5. Method of appointment :- Direct Recruitment (From candidates belonging to ST community of Kerala State Only).

Note:-Application submitted by candidates belonging to the communities other than those belonging to Scheduled Tribe Community will be summarily rejected. No rejection memo will be issued to these candidates.

6. Age Limit :- 18 - 41, Only candidates born between 02.01.1977 and 01.01.2000 (both dates included) are eligible to apply for this post. [Including the relaxation as per para 2 (i) of General Conditions].

- (ii) A pass Certificate obtained after successful completion of Nurse Cum Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala.

A pass in Certificate Course in Pharmacy (Homoeo) recognized by the Government.

Name of the candidate and the date of taking photograph should be printed at the bottom portion. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for. Candidates who have Aadhar Card should add Aadhar Card as ID proof in their profile.
