**NOTIFICATION**

The following list contains the name of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 06.08.2014 and the verification of original documents of the candidates included in the probability list published on 01.08.2016 for selection to the post of **Lower Division Clerk(SR for Differently abled)** in **Various Departments** in Kottayam District (**Category No. 258/12**) notified in the Gazette dated: 30.04.2012 on **₹ 9940-16580(PR)** arranged in the order of merit.

The Ranked List is brought into force with effect from **16/12/2016**. The Ranked List will be valid until the candidates are advised and appointed against the backlog vacancies of Differently abled candidates during the period from 01.01.2004 to 31.12.2007, as earmarked for the various categories and Differently abled groups vide GO(P) No. 07/2011/SWD dated 24.01.2011 and will remain in force for a maximum period of three years subject to the condition that the ranked list will cease to exist as and when candidates are advised and appointed against the above mentioned backlog vacancies. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But re-checking of marks will be done on payment of Rs. 75/-. The fee should be remitted in any one of the treasuries in the State under the head of account “**0051 PSC - 105 State PSC- 99 Examination Fee**” and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website/ [www.keralapsc.gov.in](http://www.keralapsc.gov.in) / or photocopied therefrom. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-checking should reach the **District Officer, K.P.S.C District Office, Devalokam, Kottayam** within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.300/- by way of chalan in any of the treasuries in the State (Head of Account 0051 PSC-800 State PSC - 99 other receipts). The duly filled up application in the prescribed form (available from the commission’s website) along with the original chalan should be submitted to the District Officer, K.P.S.C District Office, Kottayam within 45 days from the date on which the Ranked List is brought into force. A Copy of Answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

**“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of Ranked List. After the publication of the Ranked List, the request of relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.”**

Valid applications for rechecking/ photocopy of answer script addressed to **District Officer, K.P.S.C District Office, Muttambalam, Kottayam** shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/ photocopy of answer script is 30/01/2017. Application for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
