NOTIFICATION

The following is the Ranked List of candidates for selection to the post of **BEAT FOREST OFFICER** on Rs.10480-18300/- in **FOREST** Department (Direct Recruitment) in Palakkad District notified in the Gazette dated 05.02.2016 (Category No.001/2016) found suitable by the Commission and arranged in the order of merit based on the OMR Test, Endurance Test, Physical Efficiency Test and the verification of original documents of candidates included in the short list published on 05.09.2016. This Ranked List is brought into force with effect from **31.01.2017**.

The Ranked List thus published shall cease to be in force after one year from the date of finalization of the Ranked List or after one month from the date of commencement of training in respect of the last batch advised from the Ranked List within a period of one year from the date of finalisation of the Ranked List whichever is later. Candidates from this list will be advised for appointment in accordance with the Rules and Orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the List. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The entries put in column 8 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Palakkad within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

NOTE I:

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of Rs.300/- in any of the Treasuries in the State (Head of account:0051 PSC-800-State PSC-99 other receipts). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.govt.in) along with the original chalan should be submitted

to the District Officer, Kerala Public Service Commission District Office, Palakkad within 45 days from the date on which this ranked list is brought into force. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 16.03.2017. Applications received after the prescribed date will not be entertained.

Note II:

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is brought into force.

"Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.kerelapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered".

The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.75/- under the head of account "0051-PSC 105 State PSC 99 – Examination Fee", addressed to the District Officer, Kerala Public Service Commission District Office, Palakkad should reach the office on or before 16.03.2017. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

Note III:

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of requisition based on which he/she is to be advised".
