NOTIFICATION

The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Test held on 21.05.2016 and Physical Efficiency Test held on 01.12.2016 for selection to the post of Women Police Constable (Armed Police Battalion - KAP-I) (Ist NCA Rectt. for LC/AI) (Category No. 036/2016) in Police Department in Ernakulam District and arranged in the order of merit for recruitment against the NCA vacancies for LC/AI community. The Ranked List is brought into force with effect from 03.01.2017.

The Ranked List will remain in force until the candidate is advised and appointed against the vacancy notified in the Gazette dated 10.03.2016 as Category No. 036/2016 and reported subsequently due to the paucity of candidates belonging to LC/AI community in the Ranked List published on 04.05.2015 (Category No. 262/2014) for the above post.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of Rs. 300/- by way of chalan in any of the Treasuries in the State (Head of Account 0051 PSC-800 State PSC-99 other receipts). The duly filled up application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, KPSC District Office, Ernakulam within 45 days from the date on which this Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 16.02.2017. Applications received after the prescribed date will not be entertained.

A period of 45 days time to apply for re-checking of answer scripts will be allowed to candidates with effect from the date on which this Ranked List is brought into force.. The candidates can avail only one chance.

: - 2 - :

According to the existing procedure, re-valuation of answer scripts is not allowed. But re-checking of marks will be done on payment of ₹ 75/-. The fee should be remitted in any one of the Treasuries in the State under the Head of Account “**0051 PSC 105 State PSC 99 Examination Fee**” and original chalan enclosed with the application. Application for re-checking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied there from.

Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-checking should reach **the District Officer, Kerala Public Service Commission District Office, Eastern Entry Tower, South Railway Station, Ernakulam** should reach the office on or before 16.02.2017. Application for re-checking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised”.
