The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Test held on 30.4.2016 and verification of original documents of candidates included in the Probability List published on 26.7.2016 for selection to the post of L.D Typist (By Transfer) on Rs.9940-16580 in Various Departments in Kollam District (Category No.389/14) notified in the Gazette dated 10.09.2014 and arranged in the order of merit. The Ranked List is brought into force with effect from 31.08.2016.

The candidates included in this list will be advised against the 10% of the vacancies reported to this office for the post. The rules regarding the reservation of appointment contemplated in the rules 14-17 of part II of the KS & SSR 1958 are not applicable to this appointment. If sufficient number of candidates are not available to fill up the 10% reservation quota mentioned above such vacancies will be filled up by candidates included in the Ranked list prepared for open quota. In case the candidates included in the Ranked List could not secure appointment before the expiry of the Ranked List, the names of such candidates will be included at the top of the new Ranked List of the low paid employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly vide G.O(P) No.39/89/P&ARD dtd 8.12.1989.

According to the existing procedure, re-valuation of answer script is not allowed. But answer scripts will be rechecked to see that all the answers are valued and that there is no mistake in the totalling of marks for various answers if the candidate apply for rechecking remitting the prescribed fee of Rs. 75/-(Rupees Seventy Five Only) in any one of the Treasuries in the State under the Head of Account '0051 PSC-105 State PSC- 99 Examination original chalan should be enclosed with the application. Application for of answer scripts should be submitted in the prescribed available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 paper from the Commission's website/ www.keralapsc. gov.in / or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-rechecking should reach the District Officer, K.P.S.C. District Office, Kollam within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs. 300/- (Rupees Three Hundred Only) by way of chalan** in any of the Treasuries in the State under the **Head of Account 0051 PSC-800-State PSC-99 Other receipts**. The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the District Officer, KPSC District Office, Kollam within 45 days from the date on which the ranked list is brought into force. **A copy of the answer sheet will be issued only once to a candidate.** Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State /Central Government with signature, name, designation and office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisition of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

Valid Applications for rechecking/photocopy of answer script along with the original chalan receipt addressed to the District Officer, Kerala Public Service Commission District Office, Kollam shall reach this office within 45 days from the date on which the Ranked List is brought into force (i.e, the date on which the Ranked List has been approved by Commission). The last date for receipt of applications for rechecking/photorechecking/ of answer script is 14.10.2016. **Application** for the prescribed time limit and photocopy received after not in the prescribed form will not be entertained.
