The Ranked List will remain in force until candidates are advised and appointed against The NCA vacancies notified for Hindu Nadar community but remain unfilled due to paucity of candidates during the currency of Ranked List published for the post on 29.12.2010 in Idukki District as category No. 135/2008 for this post. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. Applications submitted in any other manner will not be considered. The valid applications for rechecking of answer script along with the original chalan receipt for prescribed fee addressed to the District Officer, Kerala Public Service Commission District Office, Idukki, Kattappana P.O., shall reach this office within 45 days from the date on which the ranked list has come into force (i.e. the date on which the ranked list has been approved by the Commission).

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs. 300/-**(Rupees Three Hundred only) by way of challan in any of the treasuries in the State (Head of Account **0051 PSC -800 State PSC -99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original challan should be submitted to the District Officer, K.P.S.C District Office, Kattappana P.O, Idukki within 45 days from the date on which the Ranked List is brought into force. **A copy of the answer sheet will be issued only once to a candidate.** Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceeding will be initiated against those who do so.
