:- (6) Candidates belonging to SC/ST Communities shall produce community certificates issued by the Revenue Authority and candidates belonging to Other Backward Classes who are required to produce Non – Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **05/08/2014** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
