Note :- (3) The eligible and qualified candidates who have secured **46.33 (forty six (point) three three)** marks and above are included in the Main List of the Short List and the requisite marks have been lowered to the extent necessary in respect of the supplementary lists.

Note:- (4) Candidates included in the Short List should present in person with the original documents for OT verification and Interview. Date, Time and Venue of OT verification and Interview will be intimated in due course.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list who are required to produce Non-Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same at the time of verification of original documents. SC/ST candidates shall produce Community Certificate obtained from Revenue Authorities not below the Rank of Tahsildar. Candidates in the Main List who fail to produce the required NCLC/Caste Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates. As regard to such candidates in the supplementary lists of backward castes, SC/ST, their register numbers will be deleted from the short list without further notice, if they fail to produce NCLC/Caste Certificate.

Note :- (7) Copy of answer scripts of the OMR Test held on **13/01/2015** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER II(2)4177/15/EW DATED 11/11/2015**.
