Note :- (6) Candidates belonging to SC/ST Communities shall produce Community Certificate issued by the Revenue Authority and candidates belonging to Other Backward Classes who are required to produce Non – Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **03/06/2015** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER XII(1)6454/2015/EW dated 20.05.2016**.
