Note :- (6) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents. SC/ST candidates shall produce Community Certificate in Form III issued under Rule 4 of Kerala (SC & ST) regulation of issue of Community Certificate Rules 2002 by the Competent Authority.
