Note :- (5) Candidates included in this list are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/ST/DD dated 26.09.2009 along with the other documents mentioned above at the time of verification of original documents.

Note :- (6) Copy of answer scripts of the OMR Test held on 11.06.2016 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
