They shall produce the same along with other documents mentioned above at the time of verification of original documents.

(5) According to the existing procedure, revaluation of answer scripts is not allowed. But scripts will be rechecked after the publication of the Ranked list. Detailed instructions will be published in the Ranked List Notification for the post.

(6) Application for rechecking received from candidates whose answer scripts have been invalidated will not be considered. Candidates are advised to refer Notification No : **ER II (1) 1450/15/EW dated 07/09/2015**(published along with this Notification) for the register numbers of invalidated answer scripts and reasons thereof.
