## **NOTIFICATION**

The following list contains the name of candidates found suitable on the basis of the result of Objective Type (OMR Valuation) Test held on 04.10.2012 and the verification of original documents and Suitability Assessment of the candidates included in the Probability List published on 06.03.2013 (Revised on 06.12.2013) for selection to the post of **Last Grade Servants**( **SR for PH** ) **in Various Departments** in **Ernakulam District** (**Category No. 260/2012**) notified in the Gazette dated **30/04/2012** on Rs. 8500-13210 arranged in the order of merit.

The Ranked List is brought into force with effect from 19.06.2014 The Ranked List is intended to make recruitment to the 3 % backlog vacancies of Physically Handicapped candidates during the period from 01/01/2004 to 31/12/2007 earmarked for the various categories and PH groups as G O (P) No. 7/2011/SWD dated 24/01/2011 and will remain in force for maximum period of three years subject to the condition that the Ranked List will cease to exist as and when candidates are advised and appointed against the above mentioned backlog vacancies . Rules 14 to 17 of Part II, KS &SSR are not applicable to this selection.

Candidates will be advised and appointed against vacancies notified and also against the backlog vacancies, if any, reported by the appointing authorities as earmarked in G.O. (P) No. 7/2011/SWD dated 24/01/2011.

The candidates who have obtained **56** (fifty six ) marks or above (Marks secured in the OMR Test + Weightage marks for PH candidates) have been included in the **Partially Blind** category of this Ranked List.

The candidates who have obtained **39** (thirty nine ) marks or above (Marks secured in the OMR Test + Weightage marks for PH candidates) have been included in the **Deaf/Partially Deaf** category of this Ranked List.

The candidates who have obtained **56** (fifty six ) marks or above (Marks secured in the OMR Test + Weightage marks for PH candidates) have been included in the **Orthopaedically Handicapped** [Upper extremities (Minor) Lower extremities ]category of this Ranked List.

According to the existing procedure revaluation of answer script is not allowed. But answer scripts will be rechecked to see that all the answers are valued and that there is no mistake in the totalling of marks for various answers if the candidates apply for rechecking remitting the prescribed fee of `50/- (Rupees fifty only) in any one of the Treasuries in the State by chalan

under the Head of Account "0051 PSC 105 State PSC 99 Examination Fee". The fee once remitted will not be refunded on any account .The result of rechecking will be intimated to the candidates from this office. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's Website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied therefrom. Applications submitted in any other manner will not be considered. Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A&B) relating to this selection shall remit the fees of `200/-(Rupees Two hundred only) in any one of the Treasuries in the State by chalan under the Head of Account 0051-PSC-800-State PSC-99 Other receipts. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/obtaining photocopy of answer script along with the original chalan receipt should reach the District Officer, Kerala Public Service Commission District Office Ernakulam within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission.) The last date for receipt of applications for rechecking/obtaining photocopy of the answer script is 04.08.2014 Application for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised".

Letter 'E' should be prefixed to the Register Number to denote Ernakulam District.
