Candidates are prohibited from applying for the copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

NOTE (2):- A period of **forty five days** time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of approval of Ranked List. The candidates can avail only one chance after the approval of Ranked List.
