**NOTIFICATION**

The following is the Ranked List containing the names of candidates found suitable on the basis of the Objective Type (OMR Valuation) Test held on 30/08/2014 and Physical Measurement and Physical Efficiency Test held from 12/03/2015 to 17/03/2015 and OTR verification for the post of Women Police Constable (APB-KAP IV) (Cat No.262/2014) on Rs. 10480-18300/- in Police department arranged in the order of merit. The Ranked List is brought in to force with effect from 04/05/2015.

The Ranked List shall ceased to be in force after one year from the date of finalisation of the Ranked List or after one month from the date of commencement of Training in respect of the last batch advised from the Ranked List within a period of one year from the date of finalisation of the Ranked List whichever is later. Candidates from this list will be advised for appointment in accordance with the rules and the orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advise for appointment depends on the occurrence of the vacancies, there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure revaluation of answer script is not allowed, but rechecking of marks will be done on payment of Rs. 75/-. The fee should be remitted in any one of the Treasuries in the State under the Head of Account "0051-PSC-105 State PSC- 99 Examination Fee". The marks awarded will be rechecked and results intimated.

Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry

section of the various offices of the Commission or its photo copy or downloaded and printed in A4 size paper from the Commission's web site [www.keralapsc.gov.in](http://www.keralapsc.gov.in). Applications submitted in any other manner will not be considered.

Candidates, who require the photocopy of their OMR Answer sheets will be given the same on payment of 300/- . The fee should be remitted in the Head of Account 0051-PSC- 800 State PSC- 99 Other Receipts. Valid applications for Rechecking/obtaining photocopy of answer script addressed to the District Officer, KPSC District Office, Tiger Hills Municipal Office Road, Pulikkunnu, Kasaragod - 671121 shall reach this office within 45 days from the date on which the Ranked List has come into force (i.e 04/05/2015). The last date for receipt of applications for rechecking/ obtaining photocopy of the answer script is 17/06/2015. Photocopy of invalidated answer scripts will not be issued. Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account.

Entries put in Column 8 are based on the communities specified by the candidates in their profile and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the ranked list as proved by them in their applications (Profile) should intimate the fact to The District Officer, KPSC District Office, Tiger Hills Municipal Office Road, Pulikkunnu, Kasaragod within one month from the date of publication of the Ranked List, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisition of vacancies that are pending with the Commission up to the finalization of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
