**NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 21.08.2010 and the verification of original documents of candidates included in the Probability List published on 27.09.2012 for selection to the post of **Villageman- (Category No. 508/2009) in Revenue Department** notified in the Gazette dated 31.12.2009 on **Rs. 8730-13540** arranged in the order of merit.

The Ranked List is brought into force with effect from **22.04.2013**. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The candidates who have secured **75 (seventy-five)** marks and above in the Objective Type (OMR) test have been included in the Main List of this Ranked List. The requisite marks have been lowered to the extent necessary in respect of candidates under the reservation group of communities.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be rechecked, to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers if the candidates apply for rechecking, remitting the prescribed fee of **Rs.50 (Rupees Fifty only)** in any one of the Treasuries in the State under the **Head of Account "0051- PSC- 105- State PSC- 99 Examination Fee"**.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered. The application for rechecking along with the original chalan receipt should reach the District Officer, Kerala Public Service Commission District Office, Malappuram within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission). Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as state above, the marks awarded will be rechecked and the result of the

rechecking will be intimated to the candidates from this office. Applications for rechecking received from candidates whose answer scripts have been validated will not be considered.

Candidates who wish to obtain the photocopy of their OMR answer script (Part A & Part B) relating to this selection should remit the prescribed fee of Rs.200/- (Rupees Two hundred only) in any one of the Treasuries in the State under the **Head of Account: "0051-PSC-800 Other Receipts-99-other receipts"**. The duly filled in application in the prescribed form (available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chalan should be submitted to **The District Officer, Kerala Public Service Commission District Office, Civil Station, Malappuram**. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

**The last date for the receipt of applications for rechecking / obtaining photocopy of the answer scripts is 05.06.2013. Application for rechecking / obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.**

Entries put in column 8 (community) are based on the communities specified by the candidates in their applications and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to **The District Officer, Kerala Public Service Commission District Office, Civil Station, Malappuram** within 1 (one) month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.
