NOTIFICATION

The following list of candidates found suitable by the Commission on the basis of the Objective Type (OMR Valuation) Test held on 23.10.2014 for selection to the post of Livestock Inspector Gr.II **NCA – Dheevera** in Animal Husbandry Department (Category No. 526/2011) in Kannur District on ₹ 10480 -18300/- and arranged in the order of merit. **This Ranked List is brought into force w.e.f 02.05.2016.**

The Ranked List will remain in force until candidates are advised and appointed against the NCA vacancies notified for Dheevera community but remain unfilled due to paucity of candidates during the currency of Ranked List published for the post on 04.01.2011 in Kannur District as Category No. 135/2008 for the above post. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But re-checking of marks will be done on payment of ₹.75/- (Rupees Seventy Five only) The fee should be remitted in any one of the treasuries in the State under the Head of Account '0051-PSC -105 State PSC-99 Examination Fee' and original challan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy or down loaded and printed in A4 size paper from the Commission's website/ www.keralapsc.gov.in or photocopied therefrom. Applications submitted in any other manner will not be considered. The original challan receipt together with the application for re-checking should reach the District Officer, KPSC District Office, Kannur within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates, who wish to obtain a photocopy of their OMR Answer sheet (Part A and Part B) relating to this selection shall remit a fee of ₹. 300/- (Rupees three hundred only) by way of Chalan in any of the Treasuries in the State (Head of account 0051-PSC-800 other receipts-99 Other receipts). The duly filled up application in the prescribed form (available from the Commission's Website) along with the Original Chalan should be submitted to the District Officer, KPSC District Office, Kannur within 45 days from the date on which the Ranked List is brought in to force ie on or before 15.06.2016.

A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisition of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised”.
