The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR Valuation) Test held on 27.09.2013 and Dictation Test held on 03.10.2015 for selection to the post of **CONFIDENTIAL ASSISTANT GR-II (Direct Recruitment) on Rs.10480-18300** in Various Departments in (Malappuram District and arranged in the order of merit. The Ranked List is brought into force with effect from 23.05.2016.

Application for re-checking of answer scripts should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website: www.keralapsc.gov.in or photocopied there from. The original chalan receipt together with application for rechecking should reach the District Officer, KPSC District Office, Malappuram within 45 days from the date on which this Ranked List brought into force. The fee once remitted will not be refunded on any account. Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) re-

lating to this selection shall remit the fees of Rs.300/- (Rupees Three Hundred only) in any one of the Treasuries in the State by chalan under the Head of Account "0051-PSC-800-State PSC-99 OTHER RECEIPTS. The duely filled up application in the prescribed form (Available from the Commission's Website) along with the original chalan should be submitted to the District Officer, KPSC District Office Malappuram within 45 days from the date on which the Ranked List brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of the Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
