**NOTIFICATION**

The following is the list of candidates found suitable by the Commission on the basis of the the Objective Type (OMR) Test held on 16.08.2014 and Physical Efficiency Test from 27.04.2015 & 29.04.2015 for selection to the post of **Civil Excise Officer (Excise Guard) on Rs. 10480-18300/- in the Excise Department in Alappuzha District Part - I (Direct Recruitment) (Cat. No. 534/2013)** is arranged in the order of merit. The Ranked List is brought into force with effect from **03.08.2015**.

The Ranked List thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of the new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies, and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the Ranked List till the expiry of period of three years, the duration of the Ranked List shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointments on the basis of the inclusion of their names in the list.

Entries put in column 8 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Crescent Mansion, South of Collectorate, Alissery Road, Alappuzha within one month from the date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in this list.

According to the existing procedure, re-valuation of answer script is not allowed. But re-checking of marks will be done on payment of **Rs. 75/-**. The fee should be remitted in any one of the treasuries in the State under the Head of Account '**0051 PSC-105 State PSC- 99 Examination Fee**' and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website/[www.keralapsc.gov.in/](http://www.keralapsc.gov.in/) or photocopied therefrom. Applications

submitted in any other manner will not be considered. The original chalan receipt together with the application for re-checking should reach **the District Officer, K.P.S.C District Office, Crescent Mansion, South of Collectorate, Alissery Road, Alappuzha** within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 300/- by way of chalan in any of the Treasuries in the State under the **Head of Account 0051 PSC-800-State PSC-99-Other receipts**. The duly filled up application in the prescribed form (available from the Commission's Website) along with the original chalan should be submitted to **the District Officer, K.P.S.C District Office, Crescent Mansion, South of Collectorate, Alissery Road, Alappuzha** within 45 days from the date on which this Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

***“Any candidate can relinquish his right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisition of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he is to be advised”.***

Valid applications for rechecking/photocopy of answer script addressed to **the District Officer, K.P.S.C District Office, Crescent Mansion, South of Collectorate, Alissery Road, Alappuzha** shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/photocopy of answer scripts is 16.09.2015. Application for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
