**NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type Test (OMR Valuation) held on 16/08/2014. Physical Measurement Tests, Physical Efficiency Tests and the verification of original documents of candidates included in the Short List published on 23/03/2015 for selection to the post of **Civil Excise Officer** in **Thrissur District** on ₹10480-18300 in **Excise Department** (Category No. 534/2013), Gazette Date 31/12/2013, arranged in the order of merit. The Ranked List is brought in to force **w.e.f. 03/08/2015**. The Ranked List thus prepared and published by the Commission shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of **₹75/- (Rupees Seventy Five only)**. The fees should be remitted in any one of the Treasuries in the State by chalan under the Head of Account **“0051 PSC 105 STATE PSC- 99 EXAMINATION FEE”**. The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidates from this office. Application for re-checking of answer scripts should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website: [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered. Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fees of **₹300/- (Rupees Three Hundred only)** in any one of the Treasuries in the State by chalan under the Head of Account **“0051-PSC-800 OTHER RECEIPTS-99 OTHER RECEIPTS”**. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Valid applications for re-checking/obtaining photocopy of answer script addressed to the District Officer, Kerala Public Service Commission District Office, Thrissur shall reach this office within 45 days from the date on which the Ranked List has come into force (ie. the date on which the Ranked List has been approved by the commission).The last date for receipt of applications for rechecking/obtaining photocopy of the answer script is **18/09/2015**. Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries put in column 8 (community) are based on the communities specified by the candidates in their applications and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, KPSC District Office, Thrissur within one month from the date of publication of the Ranked List, to get the benefit of reservation to which they are entitled to. In the absence of timely

information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of the Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Letter 'R' should be prefixed to the Register Number to denote Thrissur District.
