Applications submitted in any other manner will not be considered. Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fees of ₹300/- (Rupees Three Hundred only) in any one of the Treasuries in the State by chalan under the Head of Account "0051-PSC-800 OTHER **RECEIPTS-99 OTHER RECEIPTS**". A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Valid applications for re-checking/obtaining photocopy of answer script addressed to the **District Officer, Kerala Public Service Commission District Office, Thrissur** shall reach this office within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission). The last date for receipt of applications for rechecking/ obtaining photocopy of the answer script is **01.09.2016** Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained. Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of the Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
