The following list contains the names of candidates found suitable by the Commission on the basis of the result of the Objective Type Test (OMR Valuation) held on 06.08.2014 for selection to the post of LOWER DIVISION CLERK (Special Recruitment from among Partially Blind, Deaf and Orthopaedically Handicapped - Upper Extremities (Minor) and Lower Extremities only)(Category No.258/2012) on ₹9940-16580/- (P.R.) in VARIOUS DEPARTMENTS in Thrissur District notified in the Gazette dated 30.04.2012 and arranged in the order of merit. The Ranked List is brought into force with effect from 17.08.2016.

The Ranked List is prepared including qualified and Physically Handicapped candidates for filling backlog vacancies earmarked for the period from 01.01.2004 to 31.12.2007 and identified by the Government vide GO (P) No.7/2011/SWD dated 24.01.2011. The Ranked List will remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurence of vacancies, thee is no

guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of ₹75/- (Rupees **Seventy Five only).** The fees should be remitted in any one of the Treasuries in the State by chalan under the Head of Account "0051 PSC 105 STATE PSC- 99 **EXAMINATION FEE"**. The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidates from this office. Application for re-checking of answer scripts should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Kerala Public Service Commission or its photocopy or downloaded in Α4 from the Commission's and printed size paper www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Candidates who wish to obtain a photocoy of their OMR answer sheet (Part A & Part B) reating to this selection shall remit a fee of Rs.300/- (Rupees Three Hundred ony) by way of Challan in any of the treasuries in the State (Head of Account "0051 PSC - 800 State PSC - 99 other receipts). The duly filled up application in the prescribed form (available from the Commission's website) along with the original Challan should be submitted to the **District Officer**, **Kerala Public Service Commission District Office**, **Thrissur** within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission). A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answersheet which is not their own, and legal proceeding will be initiated against those who do so.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of the Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Valid applications for re-checking/obtaining photocopy of answer script addressed to the **District Officer**, **Kerala Public Service Commission District Office**, **Thrissur** shall reach this office within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission). The last date for receipt of applications for rechecking/obtaining photocopy of the answer script is **01.10.2016**. Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.
