The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 04.09.2014 and the Practical Test (H Test+Road Test) held on 13.11.2015 and verification of original documents of the candidates included in the Short List published on 28.09.2015 for selection to the post of Driver Gr.II (HDV) NCA – H.Nadar in Ernakulam District (Category No. 112/2013) notified in the Gazette dated 30.04.2013 on Rs.9190-15780 and arranged in the order of merit. The Ranked List is brought into force with effect from 08.12.2015.

The Ranked List will be in force till the candidates are advised and appointed against the vacancies that arose due to the paucity of the candidates belonging to Hindu Nadar community during the currency of the Ranked List published on 12.07.2011 (Cat. No.30/2007) for the above post.

According to the existing procedure, re-valuation of answer script is not allowed. But re-checking of marks will be done on payment of Rs. 75/- (Rupees Seventy Five Only) in any one of the Treasuries in the State under the Head of Account '0051 PSC-105 State PSC- 99 Examination Fee' and original chalan enclosed with the application. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website/www.keralapsc.gov.in/ or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-rechecking should reach the District Officer, K.P.S.C. District Office, Ernakulam within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account. Rechecking of OMR scripts invalidated will not be entertained.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 300/- (Rupees Three Hundred Only) in any of the Treasuries in the State under the Head of Account 0051 PSC-800-State PSC-99 Other receipts. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid Applications for rechecking/photocopy of answer script along with the original chalan receipt should reach the District Officer, Kerala Public Service Commission District Office, Ernakulam within 45 days from the date on which the Ranked List has come into force (i.e, the date on which the Ranked List has been approved by the Commission). The last date for receipt of applications for rechecking/photocopy of answer script is 21.01.2016 Application for rechecking/photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries put in Column 8 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Ernakulam within 1(one) month from the date of publication of the ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in this list.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State /Central Government with signature, name, designation and office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisition of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised”.

Letter ‘E’ should be prefixed to the Register Number to denote Ernakulam District.
