According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs.75/-(Rupees Seventy Five only). The fee should be remitted in any one of the Treasuries in the State under the Head of Account "0051- PSC- 105 STATE PSC - 99 EXAMINATION FEE" and original chalan should be enclosed with the application. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website/ www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the District Officer, K.P.S.C District Office, Malappuram within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account. Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & B relating to this selection shall remit a fee of Rs. 300/- by way of chalan in any of the Treasuries in the State by Chalan under the Head of Account "0051-PSC-800 State PSC-99 OTHER RECEIPTS". The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should be submitted to the District Officer, K.P.S.C. District Office, Malappuram within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of the Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised. Valid applications for rechecking/ photocopy of answer script addressed to District Officer, K.P.S.C District Office, Malappuram shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/photocopy of answer script is 12/01/2017. Application for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
