SC/ST candidates shall produce 2 copies of Community Certificate along with original certificate issued by the Tahasildar concerned.

Note 6. Copy of answer scripts of the OMR test held on 19.10.12 will be issued to those candidates who apply for the same remitting the prescribed fee after the publication of the Ranked list.
