The Register Numbers are arranged in their numerical sequence and the arrangement does not in any way indicate their respective rank on the basis of the marks secured in the said test. The original documents to prove Date of Birth, Qualification, Physical Disability, etc in respect of the candidates will be verified and their suitability will be assessed at the interview to be conducted by the Commission before the finalization of the Ranked list.

The letter T shall be prefixed to all Register Numbers to indicate Thiruvananthapuram district.
