They shall produce the same along with other documents mentioned above at the time of verification of original documents.

(5) According to the existing procedure, revaluation of answer scripts is not allowed. But scripts will be rechecked after the publication of the Ranked list. Detailed instructions will be published in the Ranked List Notification for the post.

(7) Copy of answer scripts of the OMR Test held on **30/10/2014** will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List.
