NOTIFICATION

SC/ST candidates shall produce Caste Certificate obtained from Revenue Authorities not below the rank of Tahsildar as specified in Kerala Gazette and two self attested copies of the same along with other documents mentioned above. Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate/Caste Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition Candidates. The Register Numbers of the candidates in the Supplementary Lists who fail to produce the required Non Creamy Layer Certificate/Caste Certificate will be deleted from the Probability List without further notice.
5. The candidates whose scripts are invalidated as per Invalidation Notification appended herewith are not considered for inclusion in this list.
6. According to the existing procedure, revaluation of answer script is not allowed but answer scripts can be rechecked after publication of the Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Copy of the OMR answer scripts will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List.
