Such candidates in the Main List who fail to produce the required community certificate or Non-Creamy layer Certificate (as the case may be) will not be entitled to the benefit of community reservation and will be considered as open competition candidates in the Ranked List.

7. Copy of answer scripts of the OMR Test held on 11.02.2011 will be issued to those Candidates who, apply for the same remitting the prescribed fee after approval of the Ranked list.
