The date, time and place of Physical Measurement and Walking Test will be intimated later. According to the existing procedure, revaluation of answer script is not allowed. However candidates can apply for rechecking of their answer script, after the Ranked List comes into force. Detailed instructions in this regard will be available in the Ranked List notification for this post.
