According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs.50/- (rupees Fifty only) The fee should be remitted in any one of the Treasuries in the State under the Head of Account, **"0051-PSC-105 State PSC - 99 Examination fee"**, and original Chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website: [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-checking should reach **the DEPUTY SECRETARY (EXAMINATIONS-II), KERALA PUBLIC SERVICE COMMISSION, PATTOM.P.O, THIRUVANANTHAPURAM -695 004** within 45 days from the date on which the Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the treasuries in the State (Head of Account 0051 PSC -800 State PSC - 99 other receipts). The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should be submitted to the **DEPUTY SECRETARY (EXAMINATIONS-II), KERALA PUBLIC SERVICE COMMISSION, PATTOM.P.O, THIRUVANANTHAPURAM** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for re-checking /photocopy of answer script addressed to the **DEPUTY SECRETARY (EXAMINATIONS -II), KERALA PUBLIC SERVICE COMMISSION, PATTOM.P.O, THIRUVANANTHAPURAM** shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking /photocopy of answer script is **27.04.2014**. Application for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.

The photocopy of answer script/ the result of rechecking of the candidates who apply as per rules will be forwarded/intimated from this office. Entries put in the column for community are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in this list as proved by them in their application should intimate the fact to the **DEPUTY SECRETARY (EXAMINATIONS-II), KERALA PUBLIC SERVICE COMMISSION, PATTOM.P.O, THIRUVANANTHAPURAM- 695004** within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding the discrepancies if any, the candidate will be advised as incorporated in this list.
