**NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the Objective Type Test (OMR Valuation) held on **03.10.2012** and suitability assessment held on **27.03.2013** and **25.02.2014** for selection to the the post of **Village Extension Officer Grade II (Special Recruitment for Physically Disabled Persons belonging to Partially Blind, Partially Deaf and Orthopaedically Handicapped (both Upper and Lower extremities – minor defects) Categories only) (Category No. 256/2012)** on Rs.9940-16580 in the **Rural Development** Department in **Kasaragod District** arranged in the order of merit. This Ranked List is brought into force with effect from **25.03.2014**.

The Ranked list will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years which ever is earlier. Candidates will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked, if the candidates apply for the same along with a chalan receipt for the prescribed fee of Rs.50/- (Rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account "**0051-PSC-105-State PSC 99 Examination Fee**".

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commissions Website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied therefrom. Applications submitted in any other manner will not be considered. Applications for rechecking of invalidated answerscripts will not be entertained.

Candidates who require photo copy of their OMR Answer Scripts shall remit prescribed fee of **Rs.200/-** (Rupees Two hundred only) by way of chalan in any one of the Treasuries in the State under the Head of Account “0051-PSC-800 State PSC- 99-Other Receipts”. The duly filled up application in the prescribed form (available in Commission’s website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with original chalan should be submitted to the District Officer, KPSC District Office, Kasaragod within 45 days from the date of publication of the Ranked List. Copy of the Answer Sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of Answer Sheet not of their own, and legal proceedings will be initiated against those who violate this condition.

Valid applications for **re-checking/obtaining the photo copy of answer script** addressed to the District Officer, KPSC District Office, ‘Tiger Hills’, Municipal Office Road, Pulikkunnu, Kasaragod – 671121 shall reach this office within **45 days** from the date on which the Ranked List has come in to force. The last date for receipt of application for rechecking/obtaining photo copy of the answer script is **08.05.2014**. Applications for rechecking/obtaining photo copy received after the prescribed time limit and not in the prescribed form will not be entertained. Photocopy of invalidated script will not be issued. The fee once remitted will not be refunded on any account.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
