Application for rechecking of answer script should be submitted in the prescribed format available free of cost from the enquiry section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's Website. Applications submitted in any other manner will not be considered.

Candidates who wish to obtain the photocopy of their OMR answer script (Part-A & Part-B) relating to this selection should remit the fee of Rs.200/- (Two Hundred only) in any one of the treasuries in the state under the Head of account 0051-PSC-800-OR-99-OR. The duly filled application in the prescribed form along with the Original chalan should be submitted to District Officer, KPSC District Office, Civil Station, Malappuram. Candidates are prohibited from apply for copy of answer script which is not their own, Legal Proceedings will be initiated against those who do so.

Valid applications for re checking/ Photocopy of answer scripts addressed to the District Officer, KPSC District Office, Civil Station, Malappuram shall reach this office with in 45 days from the date (That is before 16.05.2014) on which the Ranked List brought in to force.
