### NOTIFICATION

The following is the Ranked List of candidates for selection to the post of Statistical Assistant Gr II/Statistical Investigator Gr.II (Special Recruitment for Differently Abled persons-Backlog) in Economics and Statistics Department in Kasaragod District, notified in the Gazette dated 30-04-2012 (Category No.252/2012) on Rs. 10480-18300 found suitable by the Commission and arranged in the order of merit based on the OMR Test held on 25-04-2013 and certificate verification held on 21-04-2015. This ranked list is brought into force with effect from 02-06-2015.

The Ranked List will be in force until the candidates are advised and appointed against the backlog vacancies earmarked for the period from 01-01-2004 to 31-12-2007 and identified by the Govt. vide GO(P)No.7/2011/SWD dated 24-01-2011 and will remain in force for a maximum period of three years subject to the condition that the Ranked List cease to exist as and when candidates are advised and appointed against the backlog vacancies in Kasaragod District.

According to the existing procedure, revaluation of answer script is not allowed, but re-checking of marks will be done on payment of Rs. 75/-. The fee should be remitted in any one of the Treasuries in the State under the Head of Account "0051-PSC-105 State PSC- 99 Examination Fee" and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) / or photocopied therefrom. Applications submitted in any other manner will not be considered. The original challan receipt together with the application for re-checking should reach the District Officer, K.P.S.C. District Office, Tiger Hills, Municipal Office Road, Pulikkunnu, Kasaragod within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit a fee of 300/- by way of challan in any of the treasuries in the State (Head of Account 0051 PSC-800 State PSC – 99 other receipts). The duly filled up application in the prescribed form (available from the Commission's website) along with the original challan should be submitted to the District Officer, KPSC District Office, Tiger Hills, Municipal Office Road, Pulikkunnu, Kasaragod within 45 days from the date on which the Ranked List is brought into force. The copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not

be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

“Any candidate can relinquish his/her right for appointment in writing duly Attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.”

Valid application for rechecking/photocopy of answer script addressed to District Officer, K.P.S.C. District Office, Tiger Hills, Municipal Office Road, Pulikkunnu, Kasaragod shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt application for rechecking/photocopy of answer script is 16-07-2015. Application for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
